GENERAL TERMS & CONDITIONS FOR BOOKING OF A RESIDENTIAL PLOT / HOUSE / VILLA / INDEPENDENT FLOOR /DUPLEX / SHOP / OFFICE SPACE (HEREINAFTER REFERRED TO AS "SAID UNIT") IN "JINDAL GLOBAL CITY"SITUATED AT SECTOR - 33, 34 & 35, WITHIN THE REVENUE VILLAGE OF RATHDHANA, TEHSIL & DISTT. SONEPAT, HARYANA

- 1. That the intending Applicant(s) has applied for allotment of a Unit in an Integrated Township known as "**Jindal Global City**," situated at Sector 33, 34 & 35, Sonepat, Haryana (hereinafter referred to as "the Project") being developed by M/s Jindal Realty Pvt. Ltd. in collaboration with other associates companies/sister concerns (hereinafter referred to as 'Owners').
- 2. That the Developer along with other companies /sister concerns / owners have obtained necessary licenses (License No.71 of 2009 dated 30.11.2009 & license no. 24 of 2014 dated 11.06.2014) for the development over the aggregate land admeasuring approximately 214.718 acres through M/s Jindal Realty Pvt. Ltd. (hereinafter referred to as the Developer and/or the Company) from the Director, Town & Country Planning, Haryana, Chandigarh, for Development of the integrated Township Project. - 3. That the allotment of the said unit is at the discretion of the Company and the Company has a right to reject any offer/application without assigning any reason.
